OFFICE MEMORANDUM

Subject : Canvassing by Government servants in service matters-regarding.

In spite of repeated clear instructions on the aforementioned subject issued by the Government in DP&AR(GSW) vide No.B.11015/1/2012-P&AR(GSW) dated 22.07.2013, and Vigilance Department vide No.C.19012/1/2012-VIG dated 08.03.2022 and DP&AR(GSW) vide No.B.11015/1/2024-P&AR(GSW) dated 11.07.2024, It has come to the notice of the Government that some Principal/Professors/Associate Professors/Assistant Professors and staff are using political or outside influences to bear upon the superior authority to further their interest in service matters e.g promotion, transfers etc. The proper course for him/her/them is to address his/her immediate superior level who is competent to deal with the matter. An appeal or representation to a higher authority must not be made unless the appropriate lower authority has rejected, refused relief, ignored or unduly delayed the disposition of the case. Representations to still higher authorities must be submitted through proper channel. It has also been observed that the relatives of some Government servants make representations concerning service matters affecting the Government servants. It is reiterated that such activities are against the provisions of CCS(Conduct) Rules, 1964.

2. Some Colleges are using the Students to agitate the order of the Government in the matter of transfer of Teachers which is viewed seriously by the Government.

All concerned under Higher & Technical Education Department are, therefore, instructed to desist from such practices, which are against the provisions of CCS(Conduct) Rules, 1964.

If any Government servant is found violating the above provisions, disciplinary action shall be initiated against such Government servants under the provisions of CCS(Conduct) Rules, 1965.

Director, Higher & Technical Education, Secretary, Mizoram Scholarship Board and all Principals of Government Colleges are requested to bring the content of this Office Memorandum to the notice of all Government servants including employees engaged under Centrally Sponsored Schemes under their controlled for strict compliance.


