I. SEMINAR ON EMERGING TRENDS OF BUSINESS IN AIZAWL (2012-2017)

- Seminar based on group survey and research on "The emerging trends of business in Aizawl." is conducted every year by Department of Commerce in the First Semester. Students are divided into groups with 6-10 members each.

 presentation skills, teamwork etc.. Prize money for the top three is arranged by the faculty of the Department.
- This practice helps each student to gain practical knowledge about the emerging business trends and lays a foundation for their entrepreneurial endeavours in the future.
